Dear Encarni:

This letter confirms the terms of our tax engagement with you for years ending December 31 and clarifies the nature and extent of the professional services we will provide.

Our engagement is designed to perform the following services:

1. Prepare Form 990, *Return of Organization Exempt From Income Tax*, with supporting schedules.
2. Prepare any bookkeeping and adjusting entries we find necessary in connection with preparation of these returns.

The engagement letter does not cover the preparation of any financial statements, which, if we are to provide, will be covered under a separate engagement letter.

Our fees for tax services will be at our standard rates, plus related costs. Our invoices are due when you receive them. We may bill you on an interim basis prior to completion of this engagement. Finance charges of 1 ½ percent per month will be assessed on unpaid balances over 30 days old.

We will use our judgment in resolving questions where the tax law is unclear, or where there are conflicts between taxing authorities' interpretations of the law and other supportable positions. Unless otherwise instructed by you, we will resolve such questions in the Organization's favor whenever possible.

Management is responsible for the safeguarding of assets, the proper recording of transactions in the books of accounts, the substantial accuracy of the financial records, and the full and accurate disclosure of all relevant facts affecting the return to us. Management also has final responsibility for the return and, therefore, the appropriate officials of the Organization should review it carefully before an authorized officer signs and files it.

You are responsible for making all management decisions and performing all management functions; for designating an individual with suitable skill, knowledge, or experience to oversee the bookkeeping and tax services we provide; and for evaluating the adequacy and results of the services performed and accepting responsibility for such services.

If, during our work, we discover information that affects the Organization's prior-year returns, we will make you aware of the facts. However, we cannot be responsible for identifying all

items that may affect prior-year returns. If you become aware of such information during the year, please contact us to discuss the best resolution of the issue. We will be happy to prepare appropriate amended returns as a separate engagement.

Our work in connection with the preparation of the return does not include any procedures designed to discover defalcations or other irregularities, should any exist. The returns will be prepared solely from information provided to us without verification by us.

In accordance with federal law and under no circumstances will we disclose your tax return information to any location outside the United States, to another tax preparer outside of our firm for purposes of a second opinion, or to any third party for any purpose other than to prepare your return without first receiving your consent.

The IRS permits you to authorize us to discuss, on a limited basis, aspects of your return for one year after the due date of the return. Your consent to such a discussion is evidenced by checking a box on the return. Unless you tell us otherwise, we will check that box authorizing the IRS to discuss your return with us.

You should retain (from about three to seven years) all the documents, canceled checks, receipts for contributions, documents, and other data that support the information reported on the return. As you know, returns are subject to examination by the taxing authorities. In the event of an audit, the Organization may be requested to produce information or other evidence to substantiate the items reported on a return. If an examination occurs, we will represent the Organization and respond to inquiries at your request.

Certain communications involving tax advice are privileged and not subject to disclosure to the IRS. By disclosing the contents of those communications to anyone or by turning over information about those communications to the government, you, your employees, or agents, may be waiving this privilege. To protect this right to privileged communication, please consult with us or your attorney prior to disclosing any information about our tax advice. Should you decide that it is appropriate for us to disclose any potentially privileged communication, you agree to provide us with written advance authority to make that disclosure.

Should we receive any request for the disclosure of privileged information from any third party, including a subpoena or IRS summons, we will notify you. In the event you direct us not to make the disclosure, you agree to hold us harmless from any expenses incurred in defending the privilege, including, by way of illustration only, our attorney's fees, court costs, outside adviser's costs, or penalties or fines imposed as a result of your asserting the privilege or your direction to us to assert the privilege.

The return may be selected for review by the taxing authorities. In the event of an audit, you may be requested to produce documents, records, or other evidence to substantiate the items of income and deduction shown on a return. Any proposed adjustments by the examining agent are subject to certain rights of appeal. In the event of a tax examination, we will be available, upon request, to represent you. However, such additional services are not included in the fees for the preparation of the return.

You and we agree that any differences that may arise relating to services performed by us will be settled through arbitration under the procedures outlined in the Utah Uniform Arbitration Act. You agree that our total liability to you or any third party for damages arising out of this agreement from any cause shall not in the aggregate exceed the fees paid to us during the then current term of this agreement. Despite careful procedures designed to prevent and eliminate mistakes, mistakes can happen, and we agree to assist in resolving such mistakes. If our mistake causes an understatement of tax, we agree to pay penalties attributable to our mistake, but not

increased taxes and interest.

It is important for you to know that the law imposes a penalty on an organization if it files the annual return (Form 990) late. Normally, the return is due on the fifteenth day of the fifth month following the end of the fiscal year. For example, the annual return is due by November 15 for organizations with a June 30 year end. If necessary, a three-month extension to file your return can be requested. This penalty is \$20 per day for organizations having not more than \$1 million in gross receipts for the year, up to a maximum equal to the lesser of \$10,000 or 5% of the organization's gross receipts for the year. Organizations having more than \$1 million in gross receipts must pay \$100 for each day their returns are late, with the maximum penalty being \$50,000. In addition, other circumstances can cause an organization potential exposure to penalties, such as, an incomplete return, improper reporting of fundraising expenses, false information, failure to properly report the disposition of donated property, failure to make available for public inspection a copy of organization exemption applications and annual returns for the preceding three years, and activities related to self-dealing, excess benefits, and prohibited political activities. Again, management has final responsibility for filing an accurate and timely return.

The terms of this letter will continue to apply to the preparation of the above returns with respect to subsequent years, unless amended or terminated in writing by either of us.

We have the right to withdraw from this engagement at our discretion if you fail to provide us with any information we request in a timely manner, refuse to cooperate with our reasonable requests, or misrepresent any facts. Our withdrawal will release us from any obligation to complete your return and will constitute completion of our engagement. You agree to compensate us for our time and out-of-pocket expenses through the date of our withdrawal.

If the foregoing correctly sets forth your understanding of our tax engagement, please sign this letter in the space below, and return it to our office.

The Home Visitation Program provides intensive in-home parenting services to at-risk families. The Grandfamilies Program provides support and education to kinship caregivers and the children they are raising. The Adoption Program facilitates traditional infant adoptions and also assists with kinship adoption or children with special needs. Mental Health services are provided throughout all Support Service programs as needed. The organization has reduced staff of the Home Visitation program due to lack of funding in the 2017-2018 fiscal year.

Care About Childcare is a resource and referral program for parents needing childcare services. It also provides recruitment, technical assistance and training programs and quality improvement programs for childcare providers in Salt Lake and Tooele Counties.
