# Scholarships and Financial Support

## • EARLY EDUCATION PAYBACK PROGRAM

Provides reimbursement for the cost of early childhood education college credits. Students can earn up to \$3,500 per semester while working at least 15 hours in the early childhood education field.

## • CAREER LADDER APPROVED COLLEGE SCHOLARSHIP

Earn up to \$750 per <u>Career Ladder-approved course</u> for up to 12 credit hours/semester as a reimbursement payment

## • CONFERENCE REGISTRATION SCHOLARSHIP

Earn up to \$500 per year as a reimbursement payment for attending a conference in the early childhood field that meet the requirements of a <u>Professional Activity</u> on the Career Ladder.

## • ONGOING OCC SCHOLARSHIPS

The Office of Child Care (OCC) and the Utah Registry or Professional Development (URPD) provide financial support for individuals working towards professional development goals in the youth and early childhood fields. Our ongoing scholarships provide a variety of opportunities to receive funding to help pay for early childhood certificates and credentials.

## **CAC** Course Information

This email will contain the course link, handouts, code of conduct, and other applicable course information. If you do not receive an email, please contact the training department by 4pm to receive that information.

Please make sure your email address is correct on your Care About Childcare profile. This is the email that all class information will be sent.

## **CAC-CSS Class Cancelation Policy**

- Care About Childcare (CAC) ~ Children's Service Society will only cancel a class due to extreme weather, disaster, low enrollment, or if an instructor has an emergency and no instructors are available to substitute.
- It is the responsibility of the class participant to call or text 801-707-0265 to inquire whether classes have been cancelled due to weather or disaster.
- Every attempt will be made by a CAC staff member to notify class participants by text, call, or e-mail that a class has been canceled due to low enrollment.
- The decision to cancel classes because of weather or disaster will be made before 4:00 pm on weekdays and 7:30 am on Saturdays.
- The decision to cancel classes because of low enrollment will be made at least 2 days prior to the first day of the course.
- Cancelled sessions will be re-scheduled ASAP, and the participants will be notified by text, call, or email when the class is rescheduled.

CDA Cohort Program The CDA cohort is a Program where Early Childhood Educators are able to complete the CDA process with their peers. The CDA cohort will be led by knowledgeable instructors who will teach all of the training and provide assistance through workshops and support.

## What to Expect

- $\cdot$  The CDA cohort program will be offered virtually over ZOOM
- Cohort participants will participate in two classes per week throughout the cohort.
- Attending all courses is <u>required</u>
- Professional Portfolio workshops are required

• The CDA Verification Visit and Exam must be completed before the completion of the program, June 15, 2024.

· English and Spanish cohorts are offered.

## **Eligibility Requirements**

- Employed in Utah as a Teacher, Assistant Director, Director, or Family Child Care Provider
- Work with children ages 0-5
- Have a high school diploma or equivalent
- Have less than 30 hours of Career Ladder training.

## **Child Care and Americans with Disabilities Act**

The Americans with Disabilities Act (ADA) is a federal civil rights law that Congress passed in 1990. Among other things, the ADA prohibits discrimination by child care centers and family child care providers against individuals with disabilities. The ADA requires that child care providers not discriminate against persons with disabilities on the basis that they provide children and parents with disabilities with an equal opportunity to participate in the child care programs and services.

The ADA requires that child care providers provide an equal opportunity for each child to participate in the child care program and services. For further information and details visit ada.gov. On that website you can find a list of

## The Child and Adult Care Food Program (CACFP)





#### What is T.E.A.C.H.?

The T.E.A.C.H. Program:

- Links education, compensation, and commitment to improving the quality of early childcare.
- Provides scholarships for early childhood professionals to earn an AS or BS degree in Early Childhood Education.
- Is a partnership for the sharing of expenses between the recipient, their sponsoring program and T.E.A.C.H. Early Childhood® UTAH.

#### Who is Eligible for a T.E.A.C.H. scholarship?

- Any Childcare professional may be eligible if the applicant:
- Is a Utah resident.
- Has a high school diploma or a GED from an accredited school.
- Works a minimum of 20 hours per week.
- Has the support and sponsorship of the program where they are employed.
- Has the desire to earn a degree in Early Childhood Education.

#### What does the T.E.A.C.H. scholarship cover?

The scholarship provides:

Most of the cost of tuition and books, a per semester stipend for travel, paid released time support, compensation for contract completion, and counseling and administrative support.

# SAND PLAY DOUGH

Sand Play Dough

I cup of all-purpose flour I cup of fine beach sand {not craft sand} I/4 cup of salt I tablespoon of cream of tartar I tablespoon of vegetable oil I tablespoon of glycerine

3/4 cup of boiling water

Whisk the top set of ingredients together in a large boil. Add the boiling water and mix well with a wooden spoon. When cool enough to do o, dump the dough out onto the counter and give it a good knead. Let it cool completely (this will get rid of any residual stickiness) and then play!

## What is a Provocation?

Learning provocations are activities or experiences to boost children's engagement – put simply, they're spaces where children can pick up, touch and explore different objects. Think of them as an open-ended invitation to explore, wonder and be creative.
